- Can include:
 - » Medical Director Administrative Acts
 - » Student Training Programs
 - » Affirms volunteer worker coverage and defines who is a volunteer worker
- Defines coverage for professional services as the "Professional Services" described on the Declarations
- Coverage triggered by reporting of incident, rather than claim or suit
- Affirms "pure" claims made (not "claims made and reported")
- "Sexual Acts" exclusion modified
- Auditable and Non-Auditable Policies available
